## **Remote Participation and Voting**

1. The 14th AGM of the Company will be conducted fully virtual via live streaming and online remote voting using the Remote Participation and Voting facilities ("**RPV**").

Our Company has appointed Tricor Investor & Issuing House Services Sdn Bhd ("**Tricor**") as our poll administrator for the AGM to facilitate the RPV via TIIH Online website at <u>https://tiih.online</u>.

- Only members whose names appear in the Record of Depositors as at 14 November 2024 shall be entitled to participate and vote remotely at the 14th AGM or appoint proxy to participate and vote on his/her behalf.
- 3.
